

**Information on repression (killings, torture, beatings, criminal prosecutions, abductions) received by human rights defenders as of 13 January 2022:**

**Killings:**

1. **Nuraliya Aitkulova** - a civil activist, shot dead on 6 January 2022 in Almaty in the square of the Republic;
2. **Aitbay Aliyev** - civil activist, shot death in Kyzylorda;
3. **Aydar Berikovich Omarov** - shot dead in Almaty;
4. **4-year-old girl killed** during unrest in Almaty on 7 January 2022. "4-year-old girl killed. A teenage girl was injured. They were travelling in a car on Seyfullina Street at the intersection with Satpayeva Street. There were four children and an adult in the car. The car was riddled with bullets. It was on 7 January", said the Children ombudsperson, Aruzhan Sain;
5. The Children ombudsperson Aruzhan Sain reported that a child died from a gunshot wound during the unrest in Almaty. Sain said that parents were walking with their children on a metropolitan street when a shot was fired, which was fatal for the 12-year-old Kazakhstani boy<sup>69</sup>;
6. **Bekenov Almaz** - killed by a shotgun at the entrance to the akimat in Atyrau;
7. **Abubakirov Kozhantai Kozhamuratovich** - killed near the akimat, Almaty, on 5 January 2022;
8. **Tolegenov Bakbergen Azatovich** - killed in Almaty on 5 January 2022;
9. **Bazarbayev Muratkhan Abdyuly** - died from serious wounds on 6 January 2022 in Almaty;
10. **Bektursyn Margulan Bekmuratuly** - died on 5 January 2022 during protests in the Astana city square;
11. **Murat Abrayev** - killed during protests in Almaty;
12. **Nurgaliyev Kairat** and his friend **Andrey** - died during military shelling on 8 January 2022 in Taldykorgan;
13. **Yelnar Tuimebayev** - born in 1995 - died from gunfire in Almaty;
14. **Nurdauletov Kaiyrzhan** - killed by a shot to the back of the head on 6 January 2022, in Akshiy village;

**Wounds, torture:**

1. **Manat Zhanatbekovich Alimbayev** - a passerby, was injured with a machine gun. The bullets went straight through. The young man is alive.
2. **Gaziz Fatima Kasymgalyevna** -got her legs burned by a stun grenade during a protest, Aktobe;
3. **Abzal** (surname unknown) - had all his toes torn off by a stun grenade in Aktobe;
4. **Berik Abishev** - got bullet in the head, critical condition, Almaty;
5. **Beken Beysaliyev** - wounded in the hand, Almaty city;
6. **Yermekbaev Azamat Yerbolatovich** - got a rubber bullet in his eye, had an operation, after the operation he was taken to the police, where he was severely beaten, Almaty;

7. **Daulet Mukhazhanov** - a civil activist, received a gunshot wound to the back of the head, bullet lodged in the spine, both legs paralyzed. Doctors cannot remove the bullet or Daulet will die. He was told that he would be prosecuted despite his paralysed legs;
8. **Bibigul Kokanbekova** - severely beaten and located in Police Department, Semey city;
9. **Aliya Isenova** - a human rights activist, shot in Semey, her arm was crushed. Suffered a surgery. Threatened. Handcuffed to bed;
10. **Aset Abishev** - a former political prisoner and civil activist, was detained in Police Department for 5 days, beaten every day, bruises all over the body, Almaty;
11. **Zhumabekov Nurgeldy** - was shot in the shoulder, 4 January 2022;

#### **Criminal cases:**

1. **Anar Kaliyeva** - a civil activist, was detained, beaten. A criminal case under Article 272 of the Criminal Code of the Republic of Kazakhstan was initiated; she was placed in pre-trial detention facility for 2 months in Semey;
2. **Aziz Zholatov** - a son of Anar Kaliyeva, 18 years old. He was beaten by ten police officers/NSC officers until he lost consciousness. Aziz's fiancée had a gun to her head. Aziz himself was sent to the pre-trial detention facility in Semey;
3. **Kuat Shamuratov** - a civil activist from Aktobe, was taken to the temporary detention facility, Article 272 Part 1 "organisation of mass disorder", was beaten on the head with a shoulder stock during arrest;
4. **Kairat Sultanbek** - a civil activist, placed in pre-trial detention facility for 2 months, allegedly for intentional destruction or damage to property, hooliganism in a group and resisting a representative of authorities;
5. **Zhanmurat Ashtayev** - a civil activist, beaten, placed in pre-trial detention facility for the duration of investigation for allegedly organising an illegal military formation under Article 267 of the Criminal Code of the Republic of Kazakhstan;
6. **Lyazzat Dosmambetova** - a civil activist, criminal case was initiated, placed in pre-trial detention facility for 2 months, Shymkent;
7. **Ruslan Nurkanov** - a civil activist, the restriction of liberty was substituted with an imprisonment for the remaining term of 3 months and 13 days. He served his 5 days of administrative detention which began on 5 January, Ust-Kamenogorsk.
8. **Kanatkhan Amrenov** - a civil activist, sustained multiple injuries during a protest. Almaty.
9. **Almagul Kudaibergenova** - criminal case was initiated, Kokshetau.
10. **Ainur Myrzaliyeva** - a criminal case under Article 274 of the Criminal Code of the Republic of Kazakhstan was initiated, Astana.
11. **Muratbai Baimagambetov** - a criminal case under Article 272, Part 2. Now he is in the temporary detention facility, awaiting trial for preventive measures. Probably will be locked up for 2 months in pre-trial detention facility in Kyzylorda;
12. **Bianca Istanbul** - mother of many children, prosecuted under Article 274 Part 2 of the Criminal Code, Astana;
13. **Nuradin Rakai** - prosecuted for participation in a peaceful rally on 4 January 2022 in Taraz;
14. **Nurzhan Sembayev** - a civil activist, a criminal case was initiated, in Police Department his face smashed that it is impossible to recognise him, teeth were knocked out;

15. **Farit Ishmukhametov** - a civil activist, a criminal case was initiated, Semey;
16. **Bibigul Kokanbekova** - a civil activist, a criminal case was initiated, during arrest she was trampled on, kicked in the head, stomach and kidneys. Semey city;
17. **Kenzhebek Sultanbekov** - a criminal case was initiated, Semey;
18. **Tataev Nurlybai** - sent to pre-trial detention facility for 2 months, Lenger;
19. **Darkhan Valiyev** – a civil activist from Almaty. A criminal case under Article 255, Part 4 (“An Act of Terrorism”) was initiated against him. He is faces death penalty now.
20. **Raigul Sadyrbayeva** – is a member of The Human Rights movement Elimay. A criminal case under Article 272 was initiated against her. She was arrested even though she has a disability. Her life is in danger now. Sadyrbayeva faces up to 10 years imprisonment.

**Missing persons:**

1. **Zakir Askerbek** - a civil activist, went missing, Kyzylorda. At the protest, he was with the murdered Aitbay Aliyev;
2. **Ikramov Yerlan Rakhimovich** - went missing on 6 January 2022. He went to the drugstore to get some medicine, Almaty;
3. **Yeldos Musagaliyev** - went missing in Almaty;
4. **Marat Amantayevich Sadykov** - went missing, Almaty, Kazakhstan;
5. **Kuanysht Ersultan** - went missing, Almaty;
6. **Isyn Minaevich Mukhametaliyev** - missing in action, Almaty;
7. **Yamilova Rufina Albertovna** - went missing on 7 January 2022, Turkestan;
8. **Orynbasarov Nursultan** - went missing 7 January 2022, Almaty;
9. **Zhadiger Sanzhar Zhadigerovich** - went missing, the last time reported that he was in the Police Department, Almaty;
10. **Marat Amantayevich Sadykov** - 15 February 1972 - went missing on 6 January;
11. **Akylbek Sharapiyev** - detained, whereabouts unknown, Semey.
12. **Zhodatkyzy Zhazgul** - went missing, Almaty;
13. **Yerzhan Bekzat Dulatuly** - went missing 5 January 2022, Semey;
14. **Zhanat Duman Zhanatovich** - went missing, 4 January 2022, Almaty;
15. **Nurkasymov Asylkhan Bauyrzhanuly** - reportedly detained, but whereabouts unknown, Almaty;
16. **Khaidarov Yerlan Khaidaruly** - went missing on 6 January 2022, Almaty.
