having recognised on 15 July 2022 in Warsaw,

at a trial,

an action brought by Bartosz Kramek

against: "Niezależne Wydawnictwo Polskie" spółka z ograniczoną

odpowiedzialnością, domiciled in Warsaw, and Tomasz Sakiewicz

for the protection of personal rights,

considering an appeal filed by the Defendants,

against the judgment issued by the Regional Court in Warsaw

on 28 July, 2021 r., Case File Ref. IV C 2510/20

- 1. hereby rectifies, acting ex officio, an obvious typing error in item 1 of the operative part of the contested judgment, in such a way that, in lieu of the wording “nakazanie” [an order], inserts the following wording: “nakazuje” [it orders];**
- 2. revises the contested judgment as follows:**
 - a) in its part, in item 1, by supplementing the second sentence of the statement and adding “:” following the phrase: “Pana Bartosza Kramka” [Mr Bartosz Kramek] and by deleting the phrase: “w szczególności” [in particular], thus dismissing the claim in that respect,**

- b) in its part, in item 2 letter a, by ordering that the statement is printed on the second page of "Gazeta Polska" weekly, dismissing a claim for publication of a statement on the cover,
 - c) in item 3 by dismissing the claim for permanent publication of the statement directly below the article posted at:
URL.<http://www.gazetapolska.pl/14063-nowa-kampania-wrzesniowa-ujawniamy-plany-jesiennego-puczu>,
 - d) in item 7 by determining that as regards the non-property claim, the defendants shall bear the entire costs of the litigation, and that as regards the pecuniary claim, the costs shall be divided proportionally, assuming that the Defendants shall jointly and severally bear 50% of the costs and the Plaintiff shall bear 50% of the costs, whereupon the detailed calculation thereof shall be entrusted to the court registrar of the Regional Court in Warsaw,
3. dismisses the appeal in its remainder,
 4. orders that "Niezależne Wydawnictwo Polski" spółka z ograniczoną odpowiedzialnością domiciled in Warsaw, and Tomasz Sakiewicz, shall jointly and severally pay in favour of Bartosz Kramek the amount of PLN 3240 (three thousand two hundred and forty zlotys) by way of reimbursement of the costs of the appeal proceedings.
